**INDEMNIFICATION & HOLD HARMLESS AGREEMENT**

**THE MARKET PARTICIPANT NAMED BELOW SHALL INDEMNIFY** and hold the City of Renton (RENTON) and its elected and/or appointed officials, agents, employees, and/or volunteers, harmless from and shall process and defend at its own expense any and all claims, demands, suits, at law or equity, actions, penalties, loss, damages, or costs, of whatsoever kind or nature, (including but not limited to attorneys' fees and court costs) brought against RENTON arising out of, or in connection with, or incident to, the MARKET PARTICIPANT'S, or the MARKET PARTICIPANT'S agents, employees, officers, or volunteers) participation at the RENTON FARMERS MARKET, and/or the MARKET PARTICIPANT'S performance or failure to perform in a manner consistent with RENTON facility rules and regulations, following RENTON staff instructions, or any actions while at the RENTON FARMERS MARKET; provided, however, that if such claims are caused by or result from the concurrent negligence of RENTON, its elected and/or appointed officials, agents, employees, and/or volunteers, this indemnity provisions shall be valid and enforceable only to the extent of the negligence of the MARKET PARTICIPANT; and provided further, that nothing herein shall require the MARKET PARTICIPANT to hold harmless or defend RENTON, its elected and/or appointed officials, agents, employees, and/or volunteers for damages or loss caused by RENTON'S sole negligence. The MARKET PARTICIPANT expressly agrees that the indemnification provided herein constitutes the contractor's/vendor's waiver of immunity under Title 51 R.C.W., for the purposes of this Indemnification and RENTON FARMERS MARKET participation if the MARKET VENDOR PARTICIPANT is any type of business entity, whether for profit or not for profit. No MARKET PARTICIPANT is an employee, agent, representative or volunteer of RENTON or RFM based on their RENTON FARMERS MARKET participation. As independent contractors/vendors, MARKET PARTICIPANTS are not entitled to compensation, workers' compensation, insurance or benefits from RENTON or RFM.
